


Q1 - Compared to other masters degree counseling students that you have hired, CSUF










Q6 - Compared to other masters degree counseling students that you have hired, CSUF students' professional writing skills are:


Q7 - Compared to other masters degree counseling students that you have hired, CSUF


Q8 - Your perception of support that students received from CSUF faculty is:

I believe the program is able to equip the students with the skills and foundation that they need to be successful in the field.

Teaching Law and Ethics sooner and incorporating it throughout. Also, teaching them flexibility. Sometimes they are too strick with Law and Ethics and don't always know that the rules can change in county contracted specific situations.

I think the students could have some more training in writing progress notes. We are trying to provide more training on the agency side for them but they seem to struggle with that at the beginning.

Make personal counseling for students mandatory.

The program is very humanistic and at times the students have difficulty with more short-term treatment interventions that may be necessary in some cases.

Supervision requirements are higher than other, requirement for individual Supervision, No other requires it. The first semester not being able for students to count more than 40 hours is a problem for students.

Allow for more clinical hours to be counted in the first semester. Lower the number of clinical hours required as it is difficult to obtain during the traineeship. Lower the need for weekly individual supervision as it is very confining.

You have an excellent program - we did hire one of your students as our Foster Liaison. Her training and skills are exceptional. We currently also have brought on another Practicum student from your program who is proving to be excellent as well.
